# WARRANTY

### MANUFACTURING DEFECTS

Growth Covers/Winter Turf Blankets are warranted completely against manufacturing defects. Such defects include, but are not limited to, flaws in the fabric itself, improper stitching, faulty or improperly placed grommets, defective heat-sealing at seams, or incorrect size. Manufacturing defects would be apparent before use or shortly after cover is put in use and must be delineated to manufacturer at that time. Digital pictures showing defect are required. Manufacturing defect claims for covers with extended use may be denied.

Upon verification of defect, manufacturer will either replace cover, repair to customer's satisfaction, or issue full or partial credit.

Manufacturer reserves the right to make the final judgment on the stated options.

A minor flaw such as a surface scrape, small hole, or slightly pleated or minor seam opening is not cause for return. Repair tape may be used to correct the flaw quickly and, if done properly, the repaired area will be more durable than the original cover.

Warranty applies under conditions of normal use, but does not apply to problems resulting from unreasonable use, mishandling, negligence or intentional damage. During cold-weather storage, rodents may chew small holes in cover. Damage of this kind is not covered. Warranty does not apply to normal 'wear and tear' through normal use.

### ULTRA-VIOLET LIGHT BREAKDOWN

Growth Covers/Winter Turf Blankets have a limited warranty for 8 years against fabric breakdown from the ultra-violet (UV) sunlight according to the schedule below. UV breakdown is evident through brittleness of fabric, greatly reduced tear strength, and, at times, delamination of coating from base fabric.

Upon verification of defect, Manufacturer, will either credit customer, repair cover to customer's satisfaction, or replace.

Manufacturer reserves the right to make final judgment on the stated options.

Freight charges for replacement of cover are not included under warranty.

### WIND DAMAGE

Wind whiplage can cause the most damage to a cover, in some cases destroying a cover in a matter of hours. Damage due to wind force is not covered under warranty. It is the responsibility of the user to anchor the cover properly to prevent cover tearing during periods of high winds. The cover should be secured with stakes at all grommets. Whenever possible, it is advisable to also place sandbags or other weights on covers to secure them in high winds.

### STORAGE

Store covers in a dry area sheltered from damaging UV sunlight and wind.
